1. BRPS P\&C management committee actions:

2. Work undertaken to date:
2.1. Richard Palmer appointed new uniform shop Manager (paid position).
2.2. Helen Hogben has now handed over all uniform shop day to day tasks to Richard.
2.3. There have been no further large delivery delays since the summer dresses delay at the beginning of the year. Size 4 tracksuit pants went out of stock at the supplier but BME managed to get them to us within three weeks.
2.4. No second hand sales have been held this term.
3. Stock Control
4. At the end of June Richard Palmer and Helen Hogben conducted a very thorough stock control. Everything was counted twice. When compared to the flexischools report minus any returns we have stock losses of $\$ 119.45$. There were 10 items that did not match the expected stock level. We are hoping this is down to an incident in Jan when some orders were accidentally doubled up.

We have agreed with the supplier to send second hand dresses that are to a required size to use for resizing. They will alter any stock they have in China. In progress.
